



2024-25 School Year Fee Schedule
(approved 1/17/24)

An annual tuition amount for each enrollment category our program offers has been determined. The annual amount is divided into 20 equal deductions occurring over the course of the school year. Our deduction schedule is detailed below. Tuition and deduction amounts are based upon enrollment category, not attendance, or the number of days between deduction dates.

Families enrolling more than one child, will receive a 10% discount off the first child rate, for each additional child registered. No sibling discount is offered for the *Wednesday Afternoon Only* enrollment category.

Millard Public Schools employees receive a 25% discount off the first and additional child rates.
